

2024 MSRA Rule Proposals

1. Co-sanction rough stock events from January 1st- March 31st. Event must be sanctioned by an association and is open to unlimited entries. Events must be approved by the MSRA board of directors and riders must be an MSRA card holder before competing for money to count towards MSRA event standings. Cards must be purchased from the MSRA secretary before this event. A \$15.00 fee (\$10 FF & \$5 SCF) must be paid by the contestant to the event secretary and secretary must send fee to the MSRA office for money to count towards event standings. Event must be sent into the MSRA office for approval at least 30 days prior to the event. The secretary must be noted on sanction forms and put up a \$250 bond that will be refunded after the last event of the allotted season. Only one event a month may be sanctioned, it will determine by the board of directors to approve more than one event per month.
2. Page 7 H. Add Rule. President shall be compensated \$300.00 per month when there are at least 40 rodeos in one year or season with at least 50% being MSRA first approved. At Forty or less rodeos, compensation shall be a minimum of \$ 200.00 per month. The board of directors can set minimum and maximum's when rodeo counts change. When voting all directors must participate in the voting process.
3. Rodeo approvals page 42 paragraph 3. Add to rule: All rodeos that are MSRA only with no co-sanction shall receive 1% of the 10% sanction fee every year after the new year status.
4. Page 43 paragraph 5 a. Determining Entry fees. The following scale will be used in determining entry fees, in accordance with added money:

\$500 added or less	\$50-\$70 Fees (remove this line if rule #5 passes)
\$501-\$750 added	\$60-\$80 Fees (\$500-\$750 added if rule #5 passes)
\$751-\$1,000 added	\$70-\$100 Fees
\$1,001 + added	\$80-\$150 Fees
5. Page 43. Determining entry fees, remove \$300 & 301 added.
6. Page 43. Determining entry fees, iii. Add new rule rodeo must add at least \$500 per standard event.
7. Page 43 5. Entry fees B ii. Stock Charge. Change rule to read MSRA sanctioned rodeos, which add \$500 or more per event and offer all 8 events may charge a maximum of \$15 stock charge. The stock charge for Team roping will be divided between the team.

8. Page 44 5. Entry fees B iv. Team Roping Stock charge add rule. When \$500 or more per side is added in the team roping event and it is a enter once rodeo, a maximum of \$ 20 stock charge (\$10 per contestant) may be charged.
9. Page 54 paragraph 3 d. Change rule to read. 11 or more contestants & there is **\$1,800** or more in any one event, 6 places will be paid.
10. Page 28. A. Change rule to read **12 contestants** per event shall be allowed to compete at the MSFR
 - b. change to **12**
 - i. change to top **12**
11. page 43 Add rule Team roping enter once entry fees shall be:

\$500 to 750 added per side	\$80 to \$120.
\$751 or more per side	\$100 to \$200
12. Page 33 8. Rodeo approvals. Add rule. Any contractor that has 5 MSRA first approved rodeos scheduled may be allowed one 6 event rodeo per year. Contractor will be allowed to drop 1 rough stock event and 1 timed event. This rodeo will not count for all around points. Events must be marked on sanction papers prior to approval. This rodeo must be a new MSRA approved rodeo only.
13. Page 42 5. Rodeo entry fees. G. add new rule. Local entrants will be required to prepay. Payments must be received three days prior to the date of the rodeo. Payment can be made via PayPal account of the stock contractor producing the rodeo. If payments are not received, contestants will be considered a turn out.
14. Page 6 c. Election. Change the rule to, The Secretary-Treasurer shall be selected by the Board of Directors through an interview process and be paid a salary of \$500 per month (**\$1,000 a month for 45 or more rodeos June-October**) and placed under \$2,000 bond. The Secretary-Treasurer position will be a one-year term.
15. Page 25 6 b. Change sentence to read: Event rookie of the year. Rookie of the Year in each of required events shall be awarded to the first year contestant card member with the most Championship Points in a particular required event as of the end of the rodeo year and never won over **\$1,000** in any rodeo association while holding a card or permit in that association.
16. Add rule: In the Steer wrestling, Team roping, Tie down roping, Cowgirls breakaway roping, time shall be to the hundredths of a second.

17. page 63 add rule. 5) Animal Welfare. In the timed events, both boxes will be required to have $\frac{3}{4}$ "plywood (not OSB) 4'x4' sheets in the corners behind the box pads. Plywood must be fastened to the panels. If permanent arena with pipe butt bar as an established corner, rule does not apply.

18. Co-sanction timed events from January 1st-March 1st. Event must be approved by the MSRA board of directors and contestants must be an MSRA card holder before competing for money to count towards MSRA event standings. Card must be purchased from the MSRA secretary before this event. A \$15.00 fee (\$10FF & \$5 SCF) must be paid by the contestant to the event secretary and secretary must send fee to the MSRA office for money to count towards event standings. Event must be sent into the MSRA office for approval at least 30 days prior to the event. The secretary must be noted on sanction forms and put up a \$250 bond that will be refunded after the last event of the allotted season if no issues. Only a total of one event per event a month may be sanctioned, it will be determined by the board of directors to approve more than one event per month. The sanction is for the open division only. TDR, CGBKR, CBR, SW must designate which run is for the MSRA prior to the starting of the event if multiple entries are allowed. TR may designate two runs only if contestant changes partners or ends.
